ORDINANCE 23-###

**AN ORDINANCE REZONING MULTIPLE PROPERTIES FROM
R4 – MULTIPLE FAMILY AND R2 – TWO FAMILY
TO R3 – TOWNHOME RESIDENTIAL**

The City Council of West St. Paul does ordain:

SECTION 1. AMENDMENT. The Official Zoning Map for the City of West St. Paul is hereby amended to change the Zoning District designation of the properties identified in Attachment A of this ordinance from R4 – Multiple Family Residential to R3 – Townhome Residential.

SECTION 2. AMENDMENT. The Official Zoning Map for the City of West St. Paul is hereby amended to change the Zoning District Designation of the properties identified in Attachment B of this ordinance from R2 – Two Family Residential to R3 – Townhome Residential.

SECTION 3. SUMMARY PUBLICATION. Pursuant to Minnesota Statutes Section 412.191, in the case of a lengthy ordinance, a summary may be published. While a copy of the entire ordinance is available without cost at the office of the City Clerk, the following summary is approved by the City Council and shall be published in lieu of publishing the entire ordinance:

This ordinance rezones multiple existing townhomes and condominiums from R4 – Multiple Family and R2 – Two Family to R3 – Townhome Residential.

SECTION 4. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage and publication according to law.
