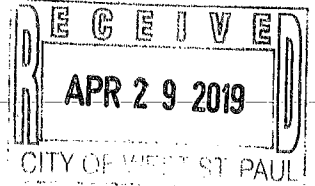


PETITION FOR LOCAL IMPROVEMENT

We, the undersigned, owners of not less than 35 percent (%) in frontage of real property abutting the Stryker Avenue alleyway between Bernard Street and Arion Street, hereby petition that such alleyway be improved by reconstructing/paving with asphalt surfacing pursuant to Minnesota Statute Chapter 429.

We understand that, according to the City's Assessment Policy, the City will assess 90% of the improvement project cost to all property owners using the alleyway. The City will fund the remaining 10% of the improvement cost.
